There are no detectable plasmid backbone sequences and no additional elements, linked or unlinked to intact cassettes, from transformation vector PV-ZMIR39. Molecular characterization confirmed that Only PV-ZMBK07 with the Cry1Ab gene was integrated into the plant genome.
